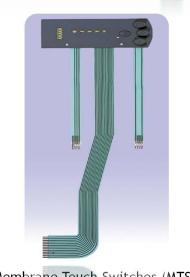

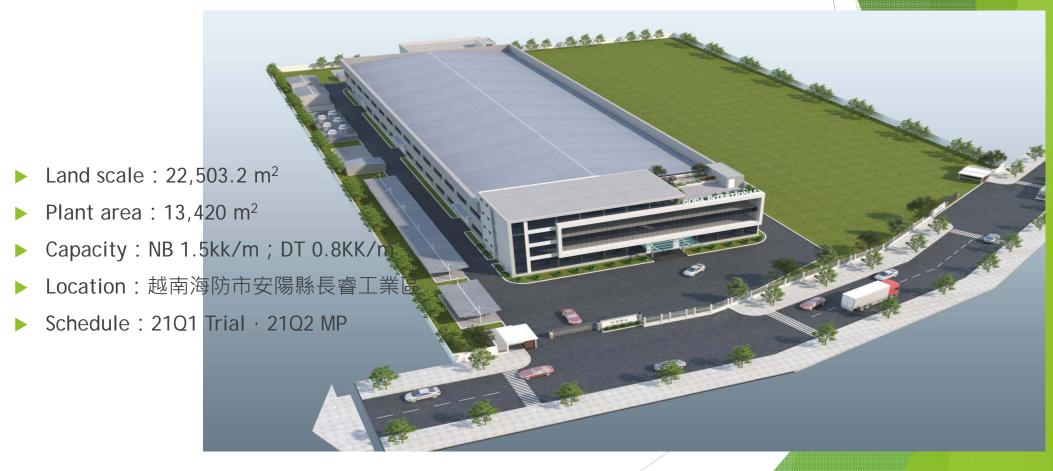

Operation Overview — Operation Advantages of Vietnam Factory

- Except Fujikura, the only MTS company with production base outside China
- ▶ large electronics factories (Wistron, Compal, Pegatron, Hon Hai) all use North Vietnam as their new overseas factories, and North Vietnam has become the first important base of the ASEAN and after the trade war. Geographical location is as follows:
 - ▶ About 2~2.5 hours from Hanoi Airport
 - About 1 hour from Cat Bi International Airport
 - ▶ About 1.5 hours from Winton International Airport in Quang Ninh Province
 - ▶ About 1 hour from Haiphong Port
 - ► About 1 hour from Beining Industrial Zone (Foxconn)
 - About 1 hour from Yongfu Industrial Zone (Quanta, Compal)
- Major customers Lite-On and Darfon have determined to establish a base in North Vietnam, which is about 0.5 hours away from VSIP (Lite-On) and about 2 hours from Darfon.
- ► The tax concession is five exemptions and four halves, and it has a tax concession for up to 9 years after the first sale.
